SONORA INDEPENDENT SCHOOL DISTRICT PROPOSITION A:

THE ISSUANCE OF \$17,900,000 OF BONDS FOR THE CONSTRUCTION, ACQUISITION, REHABILITATION, RENOVATION, EXPANSION AND EQUIPMENT OF SCHOOL BUILDINGS (INCLUDING, BUT NOT LIMITED TO, SAFETY AND SECURITY IMPROVEMENTS TO SUCH BUILDINGS) AND THE PURCHASE OF NEW SCHOOL BUSES, AND THE LEVY AND IMPOSITION OF TAXES SUFFICIENT TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS.
